Background


Since March 1973, the Motorcycle Safety Foundation (MSF) has set internationally recognized standards of excellence in motorcycle safety. Areas of activity have included rider education and training, licensing improvement, government relations, statistics and public information.

In 17 years, the Foundation has been instrumental in training more than 250 Chief Instructors and in certifying 15,000 Instructors. That instructional corps has trained over 780,000 *RiderCourse* students. *RiderCourses* are available in all 50 states, 39 of these through legislated state programs. Today, more than 3,700 MSF-certified instructors teach rider education at over 850 training centers. A national hotline, 1-800-447-4700, links callers with the nearest *Rider-Course*.

RiderCourses, however, are only one component in the MSF's national support structure to improve safety for motorcyclists. For example, the Foundation's effective licensing tests are standard in 37 states, and 36 use our motorcycle-operator's manual. As well, an MSF-developed legislation model has helped state authorities draft laws incorporating our education and training curricula.

The MSF works with the National Highway Traffic Safety Administration, state governments and other organizations — such as the National Association of State Motorcycle Safety Administrators — to promote safety programs and materials and to improve motorcycle education, testing and operator licensing.

Other support for comprehensive motorcycle safety programs includes government relations, statistics and public information.

Public Information

An informed public is a plus for motorcyclists' safety. So we tell car drivers — and motorcyclists — about sharing the road, about our *RiderCourses*, and how we can all make motorcycling safer and more enjoyable. We do this with clips and public service messages on television, in newspapers and other publications, messages like:

- ▼ The More You Know, The Better It Gets
- **▼** Ride Aware
- ▼ Look For Motorcyclists and the well-known helmet-use slogan
- ▼ Get It On.

Much of MSF's external communications is based on six fundamental documents, the Cycle Safety Information sheets (CSIs).

Three CSIs deal with general information, valid year after year: What You Should Know About Motorcycle Helmets; Riding Gear for the Motorcyclist; and The Effects of Alcohol and Other Drugs. Minor revisions are made as technology changes or new information becomes available.

Three additional CSIs are updated at least annually. It is essential, therefore, to have the most current version on file. These are: State Motorcycle Operator Licensing; Motorcycle Statistics; and State-Funded Motorcycle Rider Education Legislation.

We have other publications, brochures and educational videos. These give riders vital tips on helmet use, protective gear and safe riding techniques. Motorists, especially student drivers, can learn how to share the road safely with motorcyclists through film, video and print materials. All are available at minimal cost.
